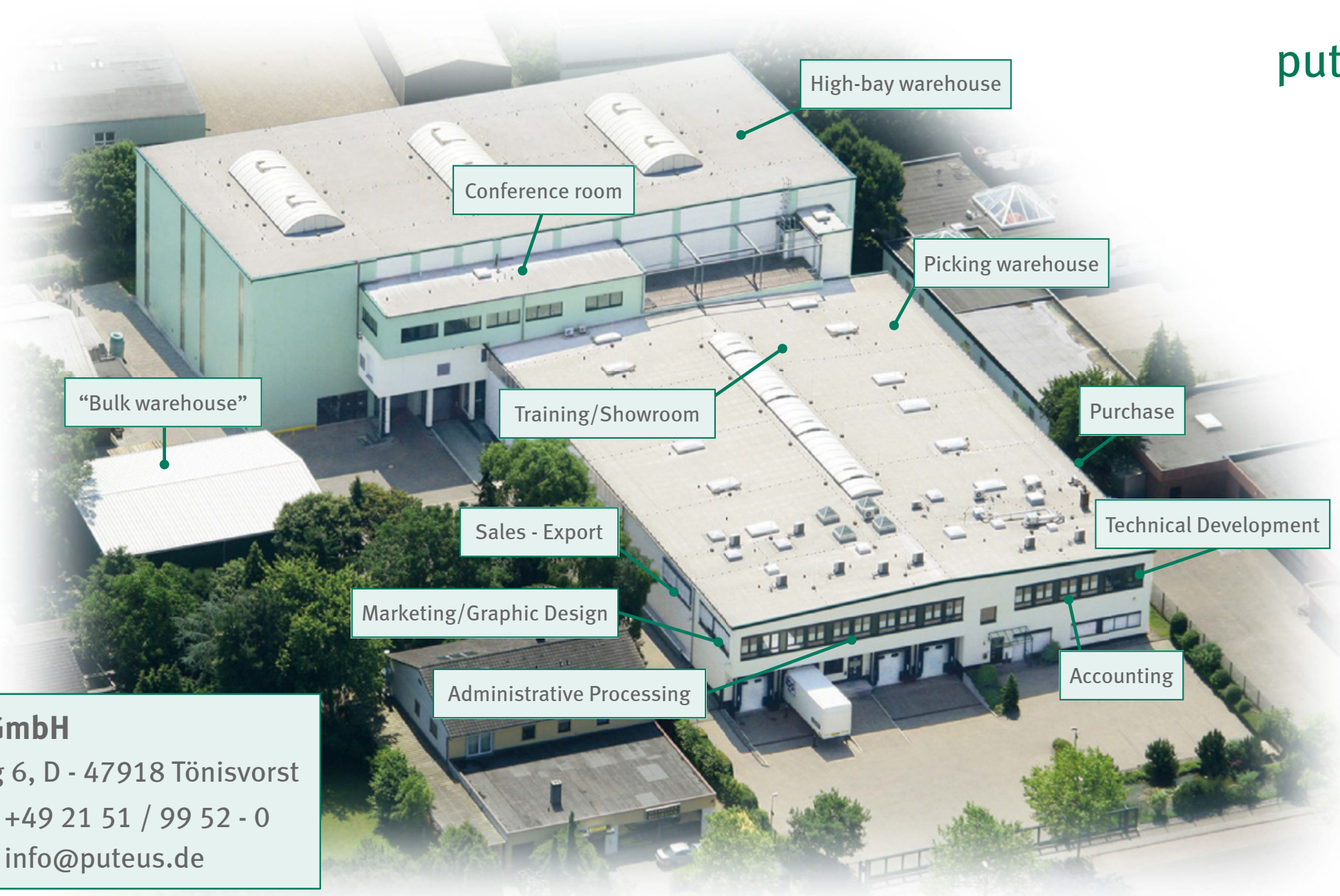
Puteus GmbH is a medium-sized manufacturer of products for the plumbing and irrigation sectors, as well as for industry and the technical trade. The company was founded in 1979 near Düsseldorf and has been based at its current location in Tönisvorst since 1997.

Technical testing facilities and an in-house design department ensure continuous quality control. Our professional, state-of-the-art storage facilities — including a 14-meter-high high-bay warehouse, a large order-picking warehouse, and an additional hall for bulk storage with a total of more than 12,000 pallet spaces—ensure clean and secure storage of our products as well as prompt fulfillment of customer orders.

Since 1998, the de Gruyter and Stach families have been investing in the continuous expansion of production sites in Germany with the aim of strengthening vertical integration, increasing value creation, and reducing supply chain issues and dependence on international suppliers.

Our in-house design and manufacturing capabilities at the highest level enable a constant stream of new technical developments as well as the timely implementation of new standards and regulations. This also strengthens our position in the area of regulatory approvals.



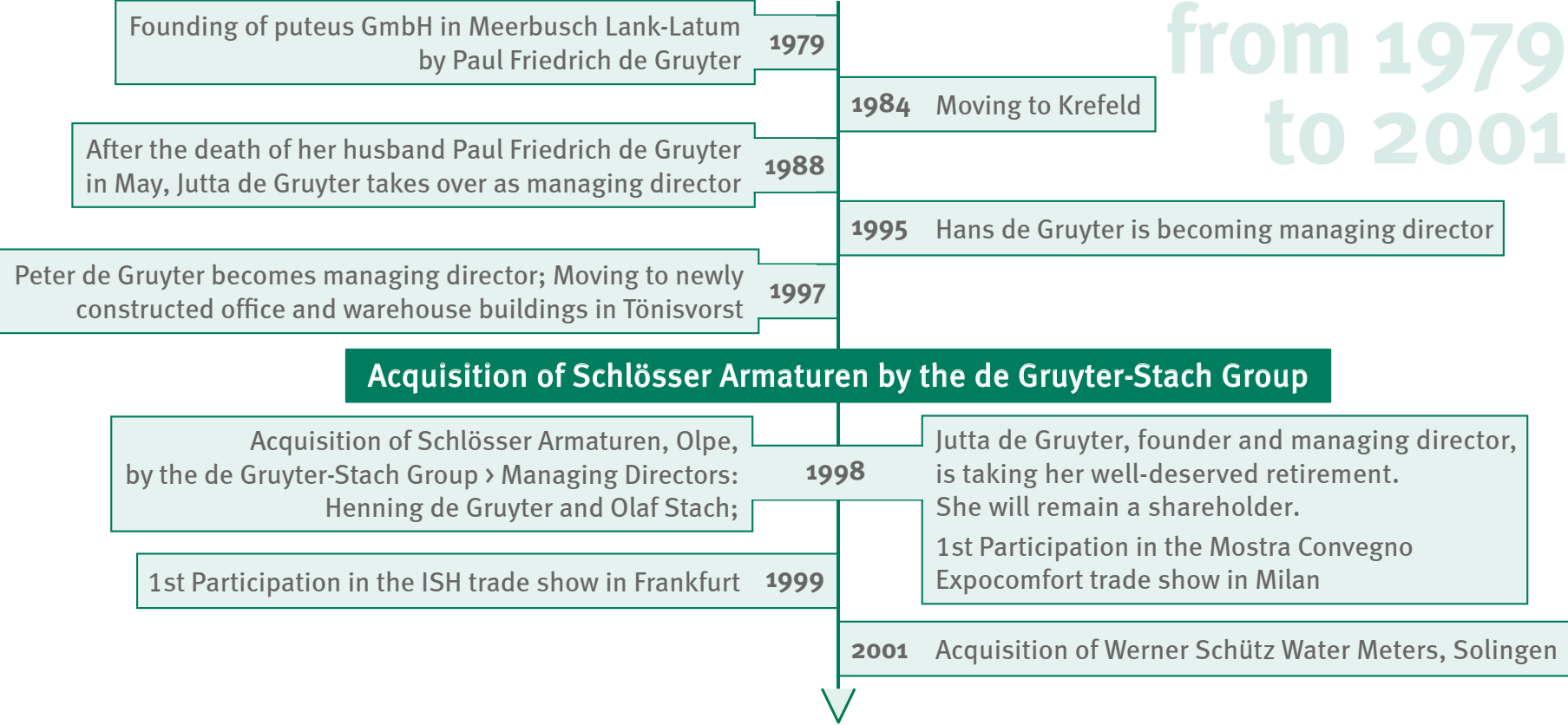
